

**IN THE 38TH JUDICIAL CIRCUIT COURT, CHRISTIAN COUNTY, MISSOURI,
 OZARK MUNICIPAL DIVISION
 UNIFORM VIOLATIONS BUREAU FINE SCHEDULE**

Pursuant to authority granted to the Municipal Judge for the City of Ozark, Missouri, pursuant to Supreme Court rule 37.495 and Section 125.120 of the Municipal Code of Ordinances of the City of Ozark, Missouri; I hereby establish the following schedule of fines that may be accepted by the Violations Bureau in lieu of an in initial appearance before this Court. Only the offenses listed below may be disposed of prior to the initial court date provided at the time of citation. All other offenses not included in this schedule, require an appearance before the Court on the date specified in the summons and/or citation.


