SECTION 410.410 INSTALLATION AND MAINTENANCE BOND; The non-itemized bond/irrevocable letter of credit shall be filed with the City of Ozark's Public Works Department prior to the approval of final plat. The developer's engineer shall provide a schedule of values for the subdivision on a signed and sealed document. subject to the approval of the public works review, maintenance bond/irrevocable letter of credit shall be provided by the developer/owner in the amount of twenty percent (20%) of the schedule of values against defects and/or failures in workmanship and materials for a period of one (1) year from the date of acceptance of such improvements. In the event the infrastructure malfunctions, the City shall enforce the security guarantee by all appropriate legal and equitable remedies, collect the same, and complete the required improvements on behalf of the City.

INSTRUCTIONS; This document shall be utilized for the submittal of the schedule of values referenced above. The appropriate number of units shall be entered. The individual values, the grand total and the 20% value will be automatically calculated. The misc. rows may be utilized for any additional item that is not listed.
